



## COLLEGE FOR THEIR CHILDREN

Children of Fallen Patriots Foundation (Fallen Patriots) provides college scholarships and educational counselling to military children who have lost a parent in the line of duty or due to service connection. We aim to bridge the gap in funding between the VA and other resources, and the total cost of undergraduate college education/vocational school.

Scholarships include, but are not limited to, assistance with: SAT/ACT prep and fees, college applications, registration fees, tuition (in-state, out-of-state, public, & private), room and board, off-campus living stipends, books, computers, tutoring, study abroad, summer enrollment, undergraduate student loans, and other miscellaneous expenses. Retroactive scholarship funding may also be available for students, including college graduates, who have already paid out of pocket for college-related expenses.

## WHO WE SERVE

Fallen Patriots serves the children (biological, step, foster, and adopted) of fallen service members - including combat, training, illness and suicide. We serve all components and branches of the military, and all eras of service (pre-9/11 and post-9/11). Fallen Patriots does not have a minimum or maximum age limit to enroll, in fact, we encourage families to enroll their children as early as possible so we can maintain contact over the years.

## HOW WE OPERATE

***Fallen Patriots does not have a competitive application process or require essays, and we do not operate on deadlines.***

Fallen Patriots provides scholarships on a continual basis throughout the year; therefore, students can apply for scholarships as needed by simply contacting our Scholarship Team. Returning scholars are encouraged to re-apply for scholarships at the end of each semester (or once final "term" grades are posted) to receive assistance for the following enrollment period. Scholarship claims take approximately 3-4 weeks to process from receipt of all required documentation.

As a friendly reminder, Fallen Patriots scholars are required to maintain a **minimum 2.0 GPA** (for the previous term enrolled) to be eligible for scholarship assistance.

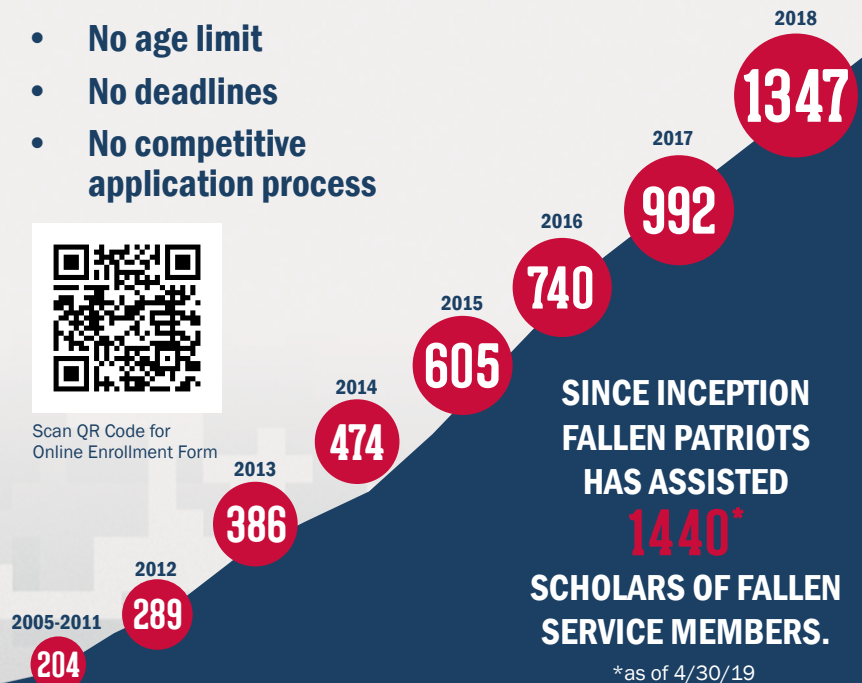
