**ALICE Recovery Fund (#ALICErecovery)**

This fund was established by United Way of Northern New Jersey in partnership with United Way of Hunterdon County to address emerging needs of **ALICE**® (Asset Limited, Income Constrained, Employed) households and those in poverty in response to the COVID-19 pandemic. The state of emergency created by the spread of the coronavirus is exposing critical shortcomings in our economy, health care system, and public education. No one is immune to its direct or indirect effects, but ALICE families are particularly vulnerable to hardship from both illness and economic disruption. These households struggled to afford the basics even before COVID-19 hit. **Across our six counties, 30 percent of households are ALICE and in poverty and United Way expects more will become ALICE as this crisis persists.**

### **Mission Asset Fund: Immigrant Families Fund**

Millions of immigrants are working on the front lines of the COVID-19 crisis, risking their health and well-being every day to keep our society going. And yet, many immigrants were left out of the CARES Act relief. The COVID-19 Rapid Response Fund is providing financial support to immigrant families who have been left out of the federal government's relief efforts. Immigrants may be eligible to receive a \$500 grant to help cover whatever is most pressing in their lives.

#### ***Eligibility***

Not eligible to receive a CARES Recovery Rebate (coronavirus stimulus check) from the Federal government.

Earned less than \$99,000 or total household income below \$198,000 in 2019.

Experienced an income disruption due to the coronavirus (COVID-19) pandemic.

Process

Sign up today at <https://missionassetfund.org/immigrant-families-grant/> Based on funding availability, we will invite people to submit a pre-application. We are reviewing

pre-applications on a rolling basis. If funding is available, we will invite eligible applicants to submit a full application. If we approve your application, we will deposit a \$500 grant directly into your bank account.
