Helen & Roberto Blandon Memorial Scholarship	All SASN Majors	✓		✓	✓	The Program Administrator or his/her designee will select scholarship recipients among full-time undergraduate students enrolled in the Newark College of Arts and Sciences. Awards will be made based on academic merit and financial need as determined by University rules in effect on the date of the award. A maximum of two awards may be made annually not exceeding a combined total of \$5,000 based on the availability of funds, scholarship awards may be renewed for up to two years, provided that the student maintains eligibility.
Henry Blumenthal Scholarship	Service to RU-N or Community	✓			✓	Available to students attending Newark College of Arts & Sciences, regardless of their major. The selection will be based on academic merit, the promise of responsible citizenship and financial need. Preference given to those students enrolled on a full-time basis. Recipients are determined by the Blumenthal Scholarship Committee. This scholarship may be renewed. Established in 1973 by the Newark College of Arts & Sciences Alumni Association whose trustees are to be known as the Committee. The Committee will consist of Dr. Blumenthal, the President of NCASAA and his chosen delegates. At least one committee member must be a woman. For detailed info. on Committee members, see file. The Committee has the power to invest, accumulate interest and make disbursements, they may solicit and accept contributions to the fund and will choose the depositories. They may only acquire investment allowed by NJ case law. Awards are chosen by the Committee, and cannot exceed the total cumulative interest. The interest accumulated (req. of Sec. 3.6) will be considered as principal. No awards until the income of the fund = \$500 or until the fund consists of the amount that would earn \$500. The interest will then be added to the principal. The Committee cannot act in conjunction with the Fin. Aid Office. The award is based on academic performance responsible citizenship and financial need. GPA should be at least a 2.8, pref. given to f-t students, the Committee must make awards within 6 weeks of the application. If N-A&S ceases to be a part of RU, the scholarship shall cease to exist.

Preference will be given to students whose permanent residence is the City of Newark or surrounding urban communities in the counties of Essex and Union and have graduate from an underperforming school district. SELECTION PROCEDURE: Selection will be made by the program administrator. Scholarships may be renewed for up to three years (four years if a five year program) at the discretion of the program administrator. Any number of scholarships in any amount may be awarded each year up to the amount of available fund income.

Up to two scholarship awards may be made each year, up to the amount of fund income available for spending.
Dr. Cecile R. Stolbof Award for Service Learning		✓				This award will be given annually to one full-time undergraduate student who has participated in service learning activities and made a significant contribution to their community through application of theoretical knowledge gained in the classroom. Recipients should be involved in academic course work which includes a service learning component that is related to the subject matter to the course. The student may work with organizations that include (but are not limited to) those that participate in the Citizen and Service Education Program at Rutgers University. SELECTION PROCEDURE: Selection will be made by the program administrator. One annual award of \$1000 will be given to a Rutgers-Newark undergraduate student.
Errol and Beulah Butterfield Fund	All SASN Majors	✓	✓			To provide financial assistance to a student who seeks a summer international leadership exchange experience through the Office of Student Life. The Program Admin, in consultation with the Dean of Student Life, will select one recipient among full time undergraduate students in the Newark College of Arts and Sciences and University College Newark. Qualified students must maintain a 3.0 GPA and be in good academic and judicial standing.
Honors College Scholarship		✓	✓	✓	✓	Scholarships are to be awarded to full-time Newark College of Arts and Sciences and/or University College Newark undergraduate students who are members in good standing of the Honor College. Students will be chosen based on academic merit as determined by the program administrator(s) and financial need as determined by the financial aid office. SELECTION PROCEDURE: Selection will be made by the program administrator(s). Scholarships may be renewed for up to three years (four years if a five year program). The number and amount of awards will be made at the discretion of the program administrator(s).

Recipients should have a minimum GPA of 3.0 and financial need as determined by the financial aid office. Qualified students should not be in the first semester of their first year. SELECTION PROCEDURE: Selection will be made by the program administrator. Two annual scholarships in the amount of \$2500 should be awarded. The scholarship is renewable for the same two students upon approval of eligibility and availability of funds. If a student becomes ineligible a replacement student will be chosen to receive the scholarship for the remaining time if funds are available.

Preference will be given to NCAS or UCN student majoring in African-American and African Studies at Rutgers-Newark. SELECTION PROCEDURE: Selection will be made by the program administrator. Scholarships may be renewed for up to three years (four years if a five year program). \$1,000 can be awarded each year, either to one or two students.

Selections will be made by the Dean of the Newark College of Arts & Sciences. Qualified students must submit appropriate University approved financial aid form by March 1 of each year to be eligible for an award. May be renewed up to four years. Award may be given to one or more qualified students in any given year, at the discretion of the program administrator. TRUE ENDOWMENT.

SELECTION PROCEDURE: Selection will be made by the Dean of the Newark Colleges of Arts & Sciences in consultation with the Office of Financial Aid. Award may be given to one or more qualified students in any given year and is renewable for up to four years.
Toni Cade Endowed Scholarship	English	✓	✓	✓	✓	Scholarship for full-time undergraduate student majoring in English, accepted to a graduate program and intends to become a writer. Awards will be based on academic merit and financial need as determined by the Office of Financial Aid. Eligible students must submit the appropriate university-approved financial aid form by March 1 of each year. Selections will be made by the Dean of Newark A&S from nominees submitted by the Department of English. TRUE ENDOWMENT
